 Thank you for your email of 1 March 2019 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000 ('the Act'). Your request was for information relating to the statutes applicable to UKAD and the Management Agreement ('the Agreement') between UKAD and the Department for Digital, Culture, Media and Sport ('DCMS'). Specifically, your request was as follows:

'In an EU-funded project aimed at developing good governance indicators for NADOs, we're trying to categorise NADOs on the basis of different parameters such as independence from government and sports movement, budget, responsibility, etc. Most of the information we need are available at the UKAD website, but we would be grateful if we under the Freedom of Information had the possibility to obtain:

- a) UKAD's statutes (if there is any); and
- b) the Management Agreement between UKAD and DMCS'
- 2. By email dated 29 March 2019 UKAD requested clarification from you, namely whether your request for 'UKAD's statutes' related to the following:
 - i. any UK legislative statutes that apply specifically to UKAD; or
 - ii. legal instruments through which UKAD has authority to conduct anti-doping activities; or
 - iii. other information.





ISO 27001 ISO 9001 3. In a return email of 1 April 2019, you confirmed that your request for 'UKAD's statues' related to *'any UK legislative statutes that apply to UKAD'*.

Summary of response

- 4. The information requested at part a) of your request, insofar as UKAD holds any such statutes, is exempt from disclosure under section 21 of the Act, as it is information accessible to you by other means.
- 5. UKAD is disclosing the current Agreement between UKAD and DCMS and a letter from the Permanent Secretary of DCMS confirming the term of the Agreement, as per point b) of your request.

Part a) of your request

- 6. UKAD was not created by statute. The framework under which UKAD operates is outlined on the UKAD website¹. Importantly, this includes the National Anti-Doping Policy, through which the UK Government has implemented its commitment to the pursuit of doping-free sport². Effectively, the Policy operates in place of a specific Act of Parliament and is the legal underpinning for UKAD's operations.
- 7. Information about the UK Government's oversight of public bodies, including nondepartmental government bodies such as UKAD, can be found at the following link: https://www.gov.uk/guidance/public-bodies-reform. As with any public authority or limited company UKAD is of course subject to a large number of statutes. All Acts of Parliament are published online by the UK Government at the following address: https://www.legislation.gov.uk/.
- 8. As these statutes are publicly available they are exempt from disclosure pursuant to your request, under s 21 of the Act.
- 9. Section 21 of the Act states:

(1) Information which is reasonably accessible to the applicant otherwise than under section 1 is exempt information.

Part b) of your request

- 10. UKAD confirms that it holds the information you have requested in part b) of your request and provides its response as follows:
 - i. The existing Management Agreement between UKAD and DCMS dated 31 December 2014 is enclosed at **Annexure A**;
 - ii. A letter from the Permanent Secretary of the DCMS dated 27 March 2015, which confirms the ongoing validity of the Management Agreement, is enclosed at **Annexure B**.

- 11. If you are dissatisfied with the handling of your request, you have the right to ask for an internal review.
