## Dear

 Thank you for your email of 16 May 2018 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000 ('the Act'). Your request was for information relating to an athlete named Shanaze Danielle Reade. Specifically, your request was as follows:

1) How many drugs test did Shanaze Danielle Reade, a former professional British Bicycle Motocross racer and track cyclist, miss between August 1st 2007 and August 1st 2008? This includes any tests she may have missed whereby UKAD accepted her explanation for doing so. Please provide the dates of these missed tests and the anti-doping agencies or international federations that attempted to carry out these drug tests. Please provide the anti-doping hearing papers if she ever had to defend herself for missing 3 drugs tests over a twelve month period.

2) How many drugs test did Shanaze Danielle Reade, a former professional British Bicycle Motocross racer and track cyclist, miss between August 1st 2006 and August 1st 2007? This includes any tests she may have missed whereby UKAD accepted her explanation for doing so. Please provide the dates of these missed tests and the anti-doping agencies or international federations that attempted to carry out these drug tests. Please provide the anti-doping hearing papers if she ever had to defend herself for missing 3 drugs tests over a twelve month period.

3) How many times was Shanaze Danielle Reade, a former professional British Bicycle Motocross racer and track cyclist, drug tested, both blood and urine





between August 1st 2006 and August 8th 2008? Please provide the anti-doping agencies or international federations that carried out these drug tests.

4) How many times was Shanaze Danielle Reade, a former professional British Bicycle Motocross racer and track cyclist, drug tested, both blood and urine between August 1st 2002 and August 8th 2006? Please provide the anti-doping agencies or international federations that carried out these drug tests.

## Response

- 2. UKAD confirms that it holds no information in relation to your request.
- UKAD was established in 2009 and therefore did not commence a testing program until it was operational in December 2009. As a result, the information we hold prior to this time is limited. Prior to UKAD's formation, the functions of the UK National Anti-Doping Organisation, including responsibility for testing, sat within UK Sport.
- 4. It may assist you to know that we hold historical testing records for limited periods of time, in accordance with the WADA International Standard for the Protection of Privacy and Personal Information ('ISPPPI'), available here. To this end, UKAD advises that its data retention policy is as follows:
  - a. to hold details concerning any unsuccessful (i.e. missed) test(s) for a period of eighteen (18) months;
  - b. to hold details concerning any successful (i.e. completed) test(s) for a period of eighteen (18) months, subject to (c) below; and
  - c. where:
    - i. a successful test results in either an Adverse Analytical Finding, Atypical Finding or possible Anti-Doping Rule Violation; and/or
    - ii. the sample collected is part of a passport program; and/or
    - iii. where UKAD stores a sample for possible future re-testing,

to hold details for a period of ten (10) years.

## Conclusion

5. If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two

months of the date of receipt of the response to your original letter and should be addressed to: Pat Myhill, Director of Operations, UK Anti-Doping, Fleetbank House, 2-6 Salisbury Square, London EC4Y 8AE. Please remember to quote the reference number above in any further communications.
