## Dear

- Thank you for your email of 20 June 2018 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000 ('the Act'). Your request was for information relating to lost and/or stolen items. Specifically, your request was as follows:
  - \* Please disclose the number of items reported lost in 2016, 2017 and to date in 2018:
  - \* For 2017 and 2018, please provide a description of each lost item and its value (or purchase price) if known;
  - \* Please disclose the number of items reported stolen in 2016, 2017 and to date in 2018.
  - \* For 2017 and 2018, please provide a description of each stolen item and its value (or purchase price) if known.

## Decision

 UKAD confirms that it holds the information requested and provides a response to each of your questions below. As per your request, the information provided with respect to the 2018 year is for the period 1 January 2018 to 20 June 2018 inclusive. For the 2016 and 2017 years, the information provided is for the calendar year (1 January to 31 December).





- 3. UKAD confirms that no items were reported stolen in the 2016, 2017 or 2018<sup>1</sup> years.
- 4. UKAD confirms that the total number of reported losses in the period 1 January 2016 to 20 June 2018 was seven. Of those seven, four were reported as lost in 2017 or 2018; the further detail that you requested with respect to these four items is set out in the below table:

	Year reported lost	Description of item	Value (£)
Item 1	2017	A single consignment comprising 4 samples lost by courier	N/A
Item 2	2017	A single consignment comprising 4 samples lost by courier. However, all 4 samples were delivered 10 days after being reported as lost	N/A
Item 3	2018	Paperwork lost by Doping Control Officer	N/A
Item 4	2018	Mobile phone (Nokia Lumia 620)	N/K – estimated at not more than £150 (purchase price)

UKAD further notes that one of the items reported as lost in the 2016 year (December) was found in July 2018.

## Conclusion
