 Thank you for your email of 9 June 2020 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000 ('the Act'). Your request was for information relating to the testing of boxers in the UK. Specifically, your request was as follows:

'I am writing to you under the Freedom of Information Act 2000 to request the following information from UKAD:

The number of drug tests carried out on boxers in the UK between March 23 and June 9 2020.

Please provide the information in the form of an e-mail.'

2. UKAD has interpreted your request as relating to tests conducted on all amateur and professional boxers in the UK. That includes boxers competing under the antidoping rules of the various British boxing governing bodies, including the British Boxing Board of Control (the 'BBBoC'), England Boxing ('EB'), the Welsh Amateur Boxing Association (the 'WABA') and/or Boxing Scotland ('BS'). It also includes tests conducted by UKAD under the jurisdiction of the International Boxing Association ('AIBA').

Summary of Response

- 3. UKAD confirms that it holds the information in your request and is disclosing that information in the table at Annex 1.
- 4. Please note that UKAD publishes testing statistics every quarter, which can be found here. This publicly available data is broken down to identify tests conducted in professional boxing (under the jurisdiction of the BBBoC), amateur boxing (under the umbrella body GB Boxing ('GBB')) and tests conducted under the jurisdiction of AIBA.
