1. We write in relation to your request for information under the Freedom of Information Act 2000 (the 'Act'), reference FOI-293.

Request for Information

2. In an email dated 1 December 2020, you requested the following information from UKAD:

"UKAD v DANIAL ROBERTS – FOI REQUEST

Can you provide full disclosure and a detailed breakdown of:-

- 1. The public monies that were spent on this case, including the testing that took place on that unfortunate evening.
- 2. What was Mr Renteurs fee in this case?
- 3. Who made the decision to press ahead with the case?
- 4. Was a cost/benefit analysis carried out before proceeding with the case?"

Response to part 1 of your request

3. Please note that as a matter of standard practice UKAD employees are not required to and do not record when and how much time they have spent on a particular matter, as is generally the case in private legal firms which charge for their time on an hourly rate. UKAD does not, therefore, hold a record of the total number of hours spent by UKAD staff dealing with this matter and is not able to calculate its internal legal and/or testing costs incurred with any degree of accuracy. UKAD is therefore unable to provide a figure as to the total expenditure in this matter.

Response to part 2 of your request

4. Mr Renteurs' total fee in this matter was £4,050.00 (inclusive of VAT).

Response to part 3 of your request

- 5. UKAD has interpreted the question: "Who made the decision to press ahead with the case?" as a request for the name of the individual at UKAD who decided that Mr Roberts had a case to answer for a violation of the Welsh Rugby Union ('WRU') Anti-Doping Rules (being the UK Anti-Doping Rules).
- 6. The decision that Mr Roberts had a case to answer for a violation of the WRU Anti-Doping Rules was not made by an individual at UKAD but following an assessment by the Legal (Case Management) team collectively at UKAD.

Response to part 4 of your request

7. No, a cost / benefit analysis was not carried out before proceeding with the case.
