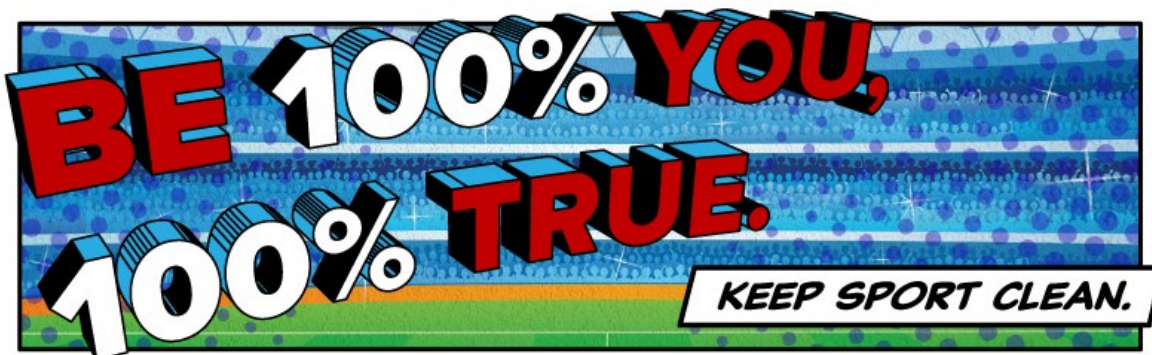
1. I would like to make a request under the Freedom of Information Act for all of your entity's expenditure over £25,000 - labelled Spending Reports on your website - for August to October 2023.
