- Thank you for your email of 16 May 2022 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000 ('the Act').
- In the context of your prior request FOI-332 (https://www.ukad.org.uk/sites/default/files/2022-05/Substance%20enquiry.pdf) you requested:

"Please provide information any information held that relates to meetings/memos/emails/texts/whatsapps etc between FOI team and any other party inside or outside UKAD, from the period commencing February 3rd - untill Monday 16th May, 2022.

I seek any information held that relates to [your name] or 'BBC journalist' from February 3rd - MONDAY 16th May, 2022"

Response

- Your request FOI-332 resulted in a neither confirm nor deny response ('NCND') in context, the reasons for which were fully set out in UKAD's response. This request appears to somewhat seek to circumvent that position and so UKAD accordingly re-asserts the section 31 (of the Act) position as stated in that letter.
- 4. In any event, and to the extent relevant, any responsive documents to the latest request would be exempted from disclosure via section 42 of the Act (i.e. legal professional privilege). The same public interest considerations in context apply here (and the relevant conclusions as to balance apply) per paragraphs 7-20 of that response.
