- Thank you for your email of 24 March 2024 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000.
 Specifically, your request was as follows:
 - 1.) Please can you provide a breakdown of all Anti-Doping Rule violations reported to you from the following Universities in each of the last 5 years: University of Stirling, University of St Andrews, University of Edinburgh, Herriot Watt University, Loughborough University
 - 2.) Please provide all information on the number of Anti-doping tests carried out on student athletes and wider sports personnel, coaches and background staff in each of the last 5 years in each of the following universities:

 University of Stirling, University of St Andrews, University of Edinburgh, Herriot Watt University, Loughborough University
 - 3.) How many of those tests returned other-than-negative (Anti-doping rule violation) in each of the last 5 years in each of the following Universities; University of Stirling, University of St Andrews, University of Edinburgh, Herriot Watt University, Loughborough University
 - 4.) How many other than negative results were dealt with by the university and how many were referred to UKAD in each of the last 5 years at each of the following universities; University of Stirling, University of St Andrews, University of Edinburgh, Herriot Watt University, Loughborough University

Response to Part 1 of your request

- 2. UKAD does not hold the information sought at Part 1 of your request.
- Please note that Anti-Doping Rule Violations (ADRVs) are determined by UKAD or the appropriate arbitral panel (e.g. the National Anti-Doping Panel, Court of Arbitration for Sport etc.). Universities therefore do not report ADRVs to UKAD.



Response to Part 2 of your request

- 4. UKAD does not hold the information sought at Part 2 of your request.
- 5. Please note that anti-doping Testing under the World Anti-Doping Code (and associated anti-doping rules, such as the UK Anti-Doping Rules) can only be carried out on Athletes, not Athlete Support Personnel or other persons.
- 6. Further, please note that when UKAD conducts anti-doping Testing, it does not record whether the Athlete concerned is a student, nor does it record any university they may attend.

Response to Parts 3 & 4 of your request

7. As a consequence of our response to Part 2 of your request, UKAD does not hold the information sought at Parts 3 or 4 of your request.

- 8. If you are dissatisfied with the handling of your request, you have the right to ask for an internal review.
