Thank you for your email of 9 July 2025 in which you requested information from UK Anti-Doping ('UKAD') under the Freedom of Information Act 2000 ('the Act'). Specifically, your request was as follows:

For the purpose of the below questions, a greyfleet vehicle can be defined as a personal vehicle, such as an employee owned vehicle, used for business purposes.

- 1. How many greyfleet miles have been travelled by your employees in the financial year 2022-2023?
- 2. How many greyfleet miles have been travelled by your employees in the financial year 2023-2024?
- 3. How much money has been reimbursed back to employees for those grey fleet miles in the financial year 2022-2023?
- 4. How much money has been reimbursed back to employees for those grey fleet miles in the financial year 2023-2024?
- 5. How many employee road accidents using a greyfleet vehicle have been reported to your organisation in the year 2022 -2023?
- 6. How many employee road accidents using a greyfleet vehicle have been reported to your organisation in the year 2023 -2024?

Summary of Response

- 2. UKAD confirms that it holds and is prepared to disclose the information sought at Parts 1-4 of your request.
- 3. However, UKAD confirms that does not hold the information sought at Parts 5 and 6 of your request.
